Notice is hereby given that GBMSD shall require only pre-qualified contractors be listed as prime contractor in the contract documents for the 2018 Interplant Force Main Fitting Repair contract. It is mandatory that all contractors who intend to be listed: (a) fully complete the Bidder's Proof of Responsibility; and (b) be approved by GBMSD in order to be on the final qualified bidders list. Bids received from firms who have not been prequalified for the proposed Project will be returned to the bidder unopened.
